- 7) 6/18/2020 Special Meeting. All BOD members in attendance. Cory Tischman Recording Secretary in place of Mary Muellner. Nate Bremer, Interim President, presided.
- a. Directors agree to hold teleconference meeting August 1, in place of Annual General Membership meeting to be held at the cancelled Chicago Convention.
  - b. Treasurer reported Embassy Suites has not yet refunded down payment of \$2000.00 for cancelled convention. She will continue to make a resolutions with Embassy Suites.
  - c. Gold Medal peony was discussed for measurable criteria and voting protocol was followed to determine winner. Winner 'Hillary', runner up 'Joker'
  - d. Nominations for next term Board of Director candidates was submitted by Cory Tischman, Nominations chair. All directors old and new have provide profiles.
  - e. Carol Adelman and Hazel Cook will not renew their Directorships for the next term to allow new directors to be elected. Hazel will remain acting Corresponding Secretary.
  - f. Motions:
    - i. Moved by Piet Wierstra to fill the election slate for the Board of Directors with all available candidates. David Michener seconded. Discussion was made expressing concern of uneven voting years. No amendments to the motion were made. The motion carried with unanimous in favor.
    - ii. Moved by Cory Tischman for the BOD to accept the slate of officers listed and will be formally ratified after the membership votes for board of directors at the General Annual Meeting. Seconded by David Michener. No discussions were made. The motion carried with unanimous in favor. Officers elect: Nate Bremer

(President), David Sorrentino (Vice President), Kris Jurik (Treasurer), Cory Tischman (Recording Secretary) and Hazel Cook (Corresponding Secretary).

- iii. Moved by Nate Bremer for the BOD to accept the resignation of Lore Sampson as APS President and director. Piet Wierstra seconded. No discussions were made. The motion carried with 11 in favor, zero against, and 2 abstained.
- iv. Moved by David Maltby for the BOD to elect Nate Bremer as Interim President until elections in August. Seconded by Kris Jurik. No discussions were made. The motion carried with unanimous in favor.
- v. Moved by Scott Parker for the APS use Covington Press for the next two bulletins. Seconded by Kris Jurik. No discussions were made. The motion carried with unanimous in favor.
