<sup>4</sup> Commercial Memberships. Commercial Membership includes a free listing on the American Peony Society Website in the Vendors section. Listing includes: link to website, contact information, logo (member supplied), sales information (member supplied) and tagline (member supplied). Advertising is available in the quarterly Bulletin for members who sell plants for planting and have a "Commercial Plant Vendors Code of Ethics" (CPVCE) file. Commercial Members who do not sell plants are not required to have a CPVCE Agreement on file. The CPVCE, which is required for all commercial vendors who sell plant material for planting, is available through the APS website.
